Tuition Payment Agreement

A tuition deposit equal to one month's tuition (or 1/9 of the total tuition) is collected upon registration. This deposit is applied to the child's last month's payment, due May 2009. Parents will have 3 choices for paying the balance of the tuition: paying annually, semi-annually or monthly. Please read the following choices and select the one which works best for your family. If you have any questions, please call 276-6350.

I understand the tuition payment options described below. I plan to pay the balance of my child(ren)'s tuition as follows:

_____ **Annual Payment**-- I will pay the balance of tuition in full on or before June 1, 2008. I understand that I will receive a \$45 discount on the year's tuition.

_____ **Semi-annual Payments**-- I will pay the balance of tuition in 2 equal payments, with the first half of the tuition due on June 1, 2008 and the second half of the tuition due on November 1, 2008. I understand that I will receive a \$40 discount on the total tuition, or \$20 off of each payment.

_____ **Monthly Payments**—I will pay the balance of tuition in 8 equal payments. I understand that families who choose this monthly payment option are required to participate in the Automated Tuition Payment Service. I understand that monthly payments will be automatically withdrawn from my account on the 5th day of each month (or the following business day) beginning in June 2008 and ending in January 2009. I hereby authorize my financial institution to make these monthly payments from the account below according to the terms described herein. I further agree to notify the Fayette Cooperating Nursery School and Kindergarten ten days prior to a scheduled payment if this account information changes. Returned payments will be charged a \$10 fee.
